### Recent U.S. import and logistics developments

#### **Tariff & Trade Policy Update:**

The use of the International Emergency Economic Powers Act (IEEPA) and Section 232 of the Trade Expansion Act of 1962 to impose tariffs remains under scrutiny. On

November 5, the U.S. Supreme Court heard arguments challenging the administration's reliance on IEEPA to levy import duties, with justices appearing skeptical of the statute's scope. Meanwhile, the U.S. and China recently reached a **framework trade deal** following the late-October meeting between Donald Trump and Xi Jinping. The agreement delays threatened 100%+ tariffs on Chinese goods and includes Chinese commitments on rare-earth exports and agricultural purchases. In exchange, the U.S. is expected to scale back certain tariffs, signaling a temporary easing in trade tensions.

#### **Logistics & Port Conditions:**

U.S. import volumes have softened heading into the holiday season. Major ports are expected to process about **1.75 million TEUs in November**, roughly 19% lower year-over-year, as importers front-loaded shipments earlier in anticipation of tariff changes. Port congestion has slightly improved—only around **8.4% of global container capacity** remains delayed at anchor, compared to roughly 10% in mid-year. However, many ocean carriers have begun cutting overall capacity, particularly outside of Asia–U.S. West Coast routes, suggesting a cautious outlook amid moderating consumer demand.
